## **NURTURY ADMISSION AGREEMENT 2024-2025**

I hereby agree that the Moraga Valley Presbyterian Church created and organized the Nurtury in response to the growing need in our community to provide quality preschool education for children. The Nurtury Advisory Committee (NAC), comprised of the Nurtury Director, Nurtury Teacher, Nurtury Parents, and members of the church, are responsible for overseeing this non-profit program. The NAC sets tuition and policies. I understand that the Nurtury operates solely by funds provided by tuition. Tuition and fees are used by the Nurtury to provide for the best teachers, equipment and supplies available.

Nurtury Preschool is a preschool/child care center licensed under the California Department of Social Services to provide child care for children 2 years old to entering Kindergarten. For this purpose, "child care" means non-medical care for children who are in need of personal services, supervision, age-appropriate activities and education.

Tuition is established as a yearly fee, but is divided into ten monthly payments (August-May). Tuition payments are due on the 1st of each month. Any modifications in the tuition rates will be provided to parents/legal guardians 30 days prior to modifications. Additional fees, such as late payment or pick up fees, failure to check a child in/out, are outlined in the Parent Handbook. At the time of registration, parents will pay a One-Month Tuition Deposit, and a Non-Refundable Registration fee in the amount of \$15 Returning Students and \$150 for New

Students. Refund policies and deadlines are outlined in the Registration Form. There is no tuition discount or adjustments for any absences due to holidays, illness, vacation or school closure.

I understand that the Nurtury Advisory Committee (NAC), is responsible for annually evaluating and setting tuition rates, and will notify parents in the Registration materials of any increases for the coming school year.

I acknowledge that my child must be two years old to begin the Nurtury Program.

I acknowledge the conditions under which this agreement may be terminated are the following: (1) if the financial policy is not heeded, (2) if a child poses a health or safety threat to others, or (3) under special circumstances, determined by the Director and/or the Nurtury Advisory Committee (NAC).

I agree to notify the Nurtury 30 days in advance of withdrawal or schedule changes, should such an event occur, or pay the difference in monthly tuition fee.

I understand and acknowledge that Nurtury is a licensed childcare center and that, under California law, the California Department of Social Services has the right at any time, without notice or prior consent, to 1) privately interview children or staff at any licensed child care center; 2) inspect and audit children's records; 3) observe the physical condition of children, including conditions which could indicate abuse, neglect or inappropriate placement; and; 4) have a licensed medical professional conduct physical examinations of children.

I have received and read the Nurtury Parent Handbook. I hereby agree to comply with all the rules and regulations of Moraga Valley Presbyterian Church Nurtury Preschool (as set forth in the Nurtury Handbook) regarding fees, attendance, health, parking/driving and will be responsible for checking my child in and out of the Nurtury each day unless I have given authorization specifying a person other than myself has my permission to take my child from the Nurtury.

This Admission Agreement is required by the State of California. Every child must have a signed/dated Agreement in their file no later than seven days following admission (or specific date set by Nurtury). A new Admission Agreement is required each year.

This Admission Agreement, is entered into as of the day of the child's start date and remains in effect for one year, by and between Nurtury Preschool and the Parent(s).
